Conditions of Participation

§ 1 Admission

Participation in the Streetlife Festival is open to vendors, institutes and groups, henceforth to be referred to as "A", who are conducive to the character of the event and who embrace the themes of „alternative mobility", and „a lively street", and who contribute to the improvement, protection or stabilization of the environment and the improvement of sustainability.

Content, services and offers of A are to be precisely described in the application form. The festival organizers, henceforth to be known as V, reserve the right to prohibit admission or to remove items from the admission request when the previously referenced conditions are not fulfilled. When, after the beginning of the event, it is made apparent that the agreed-upon conditions are being violated, the appearance can be terminated or items can be removed or changed at the organizer's discretion. The obligation of payment of the full stand fee will, however, remain. A can also be denied admission when there are already too many organizations similar to A registered. Registration makes a strict, singularly valid contract which begins from the moment that A is accepted or from the moment that the mailing of the registration invoice to A is completed.

§ 2 Cancellation of Application

When A cancels their application 4-8 weeks before the event, a processing fee of 50€ will be assessed. When the cancellation occurs fewer than four weeks before the event, A will be expected to pay the agreed-upon fees in full.

§ 3 Length and Setup of Event

The event begins on 11.09.10 at 16:00 and ends on 12.09.10 at 20:00. Setup takes place on Saturday, 11.09.10 between 12:30 and 15:30, and on Sunday, 12.09.10 between 8:00 and 11:00. Dismantling and break down begins on Sunday at 20:00 and must be completed by 22:00.

§ 4 Use of Space

(1) A has the right to use the agreed upon space with the agreed upon conditions within the framework of the Streetlife Festival. The space will be allocated by the event organizers, taking all requests and wishes into consideration. Desired changes after the allocation of space has been completed can be made through V.

(2) Advertisement by A can only occur within 2 meters of the reserved exhibition area and must follow the registered conditions. Flyer advertising on and around the festival area is strictly prohibited. Visual or audio performances and propaganda actions must be approved by V.

(3) Sale of food and drink is prohibited.

(4) Sale of products is strictly prohibited by city regulations. Artists and craftsmen may obtain a special sales permit from V, free of charge.

§ 5 Stand Maintenance

(1) The setup and maintenance of setup is the responsibility of A. All related costs are the responsibility of A.

(2) A is responsible for the organized and timely setup and dismantling of the stand. Electric cable must be covered by a protective mat to prevent tripping.

(3) Health and fire regulations are to be met and are the responsibility of A. Use of straw or liquid gas is strictly prohibited. Disregard for these regulations can result in the immediate dismantling and removal of the stand.

(4) Legal provisions must be obeyed. The stand is the full responsibility of A, sales of any kind are strictly prohibited.

(5) All cars or transport vehicles must be removed from the festival area before the festival begins.

§ 6 Dismantling of Stand

(1) At the end of the festival, A is responsible for returning the reserved space to its original condition.

(2) All non-accidental damage (i.e. street damage.) caused by A or any assistants of A must be remedied by A.

(3) Contingent accrual of license fees from KVR München are the responsibility of A.

(4) Clean up and disposal of incidental refuse and litter is the responsibility of A.

§ 7 Event Cancellation

(1) The contract parties are aware of the possibility that in the case of particularly extreme conditions (hail, thunderstorm) the festival will be cancelled. In this case, V is required to cancel the event 24 hours before the planned opening time. In this case 50% of the stand fee will be returned. Cancellation of the event will be made public on Friday, 08.06.07 after 14:00 with a posting on the homepage or can be inquired about under the telephone number 089-890-668-0.

§ 8 Liability

(1) V assumes no liability for the workers and participants of the individual stands. The risk for personal injury on the action spaces is assumed by A. It is recommended that A obtain liability insurance or inform the participants that no liability can be assumed. This can be accomplished through information boards or the undersigning of a liability waiver.

(2) A assumes all liability for the security of the stand and the displayed articles and for protection from harm by third parties. It is recommended that A pack all display articles and store them under the table or cover them during the night.

(3) Only VDE (Association of German Electricians) -authorized electronic devices and cables are approved for use by A. The use of cable drums is prohibited. A assumes responsibility for collective damages caused by defective electronic devices or deficient protective covering.

The same applies for damages caused by deficient use of water services or protective covering thereof.

§ 9 Miscellaneous

Music performances as well as amplified announcements or moderation of any type must be approved by V. From 22:00 until 11:00, all music performances are prohibited due to noise regulations. Approved performances are subject to all mandatory noise regulations, A assumes all responsibility for adherence to these conditions at the individual stands.

§ 10 Written Form

Any conditions or agreements outside of the written terms of these conditions of participation is invalid. Verbal side agreements will not be regarded as valid. Changes or additions to these conditions require written approval. This stipulation is also valid for this contract clause.

§ 11 Severability Clause

Should individual provisions of this contract prove to be entirely or partially ineffective or inexecutable, this should not affect the efficacy of the contract as a whole. The contract parties are required in this case to replace the ineffective or inexecutable provisions with effective or executable regulations which most closely follow the function of the original regulations within the framework of the contract as a whole. Corresponding action is also valid for possible gaps in the contract.

§ 12 Applicable Rights, Place of Execution, Jurisdiction.

(1) This contract is subject with respect to its execution and in all of its effects exclusively to the German law code.

(2) Place of execution for all of the given restrictions of this contract is Munich.

(3) The jurisdiction for all complaints against or related to this contract is exclusively Munich.

The contract parties are aware that there is a possibility of cancellation of the festival due to lack of funds through sponsoring, fees and subsidies. In this case, the organizer is required to cancel the event 6 weeks prior to its scheduled date. There is no guarantee for damages.
